

# UFP-Edge™ True STK and UFP-Edge™ Clear Limited Warranty



**Important: This is your warranty certificate. Attach your invoice and proof of warranty.**

## WARRANTY

UFP Warranty Corporation (the "Warrantor") warrants to the original purchaser of its UFP-Edge True STK and UFP-Edge Clear ("Products") against manufacturing defects that cause rot, corrosion, delamination or excessive swelling for the durations set forth below. This Warranty is only offered to the original purchaser of the Products and may not be transferred or assigned by the original purchaser.

## WARRANTY PERIOD

This Warranty shall be offered for the following durations and subject to the Prorated Refund Schedule herein:

UFP-Edge True STK	15 Years
UFP-Edge Clear	25 Years

Warrantor agrees, at its option, to replace the defective Product or refund the applicable percentage of the purchase price of the Product.

## WARRANTY EXCLUSIONS & CONDITIONS

This Warranty does not cover costs of delivery and installation, redelivery, removal or reinstallation. Warrantor's sole obligation is limited to replacement of the Product or refund of a percentage of the purchase, and Warrantor shall have no further liability or obligation except as expressly stated herein. The Warrantor may elect to refund the percentage of the original purchase price listed on the Prorated Warranty Schedule in lieu of replacing the Product.

The Warranty does not apply to any Product that:

- has damage resulting from improper storage or handling prior to installation.
- is damaged by physical abuse, acts of God, acts of war, or other chemical or biological factors.
- has not been installed in accordance with Warrantor's installation guidelines.
- has minor imperfections that do not affect the Product's performance.
- has been abused or placed under or subjected to abnormal use conditions or has surface damage or surface punctures.
- has been improperly painted, coated, used, modified or otherwise treated in any manner other than as intended by Warrantor.
- has been directly or indirectly exposed to extreme heat (more than 175 degrees Fahrenheit).
- has come into contact with corrosive substances.
- has been installed in-ground or with soil contact.
- has been installed where the material is usually immersed in water or subjected to excessive moisture.

Failure to follow any restrictions or warnings supplied with the Product shall make the Warranty null and void and of no further effect. Warrantor reserves the right to investigate any claim and to inspect the installed Product for which the claim is made. The Consumer assumes all risk and liability associated with construction or use of this Product. The Consumer or contractor should take all necessary steps to ensure the safety of everyone involved in the project, including, but not limited to, wearing the appropriate safety equipment.

Warrantor shall not be liable for any incidental or consequential damages arising out of the use or ownership of this Product. Some states do not allow limitations on how long an implied warranty lasts and/or do not allow the exclusion of incidental or consequential damages, so the above limitations and exclusions may not apply to you. This Warranty gives you specific legal rights, and you may also have other rights that vary from state to state.

## CLAIM PROCEDURE

To make a claim under this Warranty to receive replacement Product, the original owner must, within 30 days of actual or constructive notice of damage covered by this Warranty, do the following:

- 1) Prepare a letter that includes the following information:
  - a) A list of the number of pieces and the size of each piece for which the claim is made.
  - b) Proof of Purchase of the Product, as shown on the original dated invoice.
  - c) Photographs of the allegedly defective Product.
