

# UFP-EDGE PRIMED 15-YEAR LIMITED WARRANTY



**Important: This is your warranty certificate. Attach your invoice and proof of warranty.**

## 15-YEAR LIMITED WARRANTY

This warranty is made to the first purchaser of the UFP Edge Primed siding and trim product (the "Product") and to the first owner of the structure to which the Product is applied. Subject to the terms, conditions, exclusions and limitations set forth herein, UFP Warranty Corporation ("Warrantor") warrants for a period of FIFTEEN (15) years from the date of purchase of the Product (the "Warranty Period") that when used for its intended purpose, properly installed and maintained according to Warrantor's published installation instructions and applicable building codes, and subjected at all times to normal exposure conditions, the Product is:

- **PEEL AND FLAKE RESISTANT** – primer coat will not peel or flake from substrate;
- **WASHABLE** – dirt can be removed without damaging the primer finish;
- **RESISTANT TO CHALK WASHDOWN** – will not cause chalk stains on surfaces below coating

**IN THE EVENT THE PRODUCT FAILS TO CONFORM TO THIS LIMITED WARRANTY, WARRANTOR, AS ITS SOLE LIABILITY AND IN LIEU OF ANY DIRECT OR INDIRECT, INCIDENTAL, SPECIAL OR CONSEQUENTIAL DAMAGES, WILL FURNISH EITHER SUFFICIENT REPLACEMENT PRODUCT OR A REFUND OF THE PURCHASE PRICE, AT ITS OPTION. THIS LIMITED WARRANTY DOES NOT COVER LABOR COSTS ASSOCIATED WITH THE REMOVAL, INSTALLATION, REPAIR OR TOP-COATING OF DEFECTIVE OR REPLACEMENT PRODUCT OR ANY OTHER RELATED EXPENSES.** Warrantor's obligations under this Limited Warranty shall in no event exceed the purchase price of the original Product associated with the specific job which gives rise to a claim under this Limited Warranty. Any replacement product provided in response to a warranty claim shall be warranted only for the balance of the Warranty Period under this Limited Warranty. As consideration for any refund or material replacement pursuant to this Limited Warranty any such refund or material replacement shall constitute a full settlement and release of all claims you may have for damages or other relief, and shall be a complete bar to any litigation filed subsequently to your acceptance of such refund or material replacement. **WARRANTOR DOES NOT MAKE ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS OF THE PRODUCT FOR A PARTICULAR PURPOSE. THERE ARE NO OTHER WARRANTIES WHICH EXTEND BEYOND THE DESCRIPTION IN THE FACE HEREOF. This warranty gives you specific legal rights and you may also have other rights which vary from state to state.**

## LIMITED WARRANTY CONDITIONS

In order for this Limited Warranty to apply, all of the following must occur:

- All exposed sides/ends of the Product are properly primed, including any side/end that is exposed for any reason after the time of purchasing from Warrantor;
- No Product that exhibits any defect or damage, however minor, is installed;
- All field-cut edges are re-primed by a contractor with expertise in the relevant field with one coat of at least six wet mils of Olympic PPG primer prior to installation in accordance with the primer manufacturer's published procedures for surface preparation and application;  
***Important** Coating thickness must be measured using a film gauge and proof of the results at the time of measurement must be recorded by the contractor and provided to Warrantor in conjunction with any claim hereunder.*
- The Product and any field primed areas of the Product must be top-coated with 2 to 3 dry mil application of a high-quality, 100% acrylic coating by a contractor with expertise in the relevant field within 60 days of installation, and must be done in accordance with the primer manufacturer's published procedures for application and specifications as well as in accordance with the top-coat manufacturer's published instructions;  
***Important** The top-coat must be measured at the time of top-coat application with a film gauge and proof of the results at the time of measurement must be recorded by the contractor and provided to Warrantor in conjunction with any claim hereunder.*
- The top-coat must be applied when the material has a moisture content of 15% or less;
- The top-coat must be applied using an authorized machine applicator and in accordance with the paint and primer manufacturers' applicable procedures and specifications;  
***Important** The date, type of top-coat used and weather conditions (temperature, humidity, etc.) must be recorded by the contractor at the time of top-coat application and provided to Warrantor in conjunction with any claim hereunder.*

## **LIMITED WARRANTY EXCLUSIONS**

This Limited Warranty does not cover failure or damage to the Product arising out of any of the following: mistreatment, misuse, vandalism or accident; excessive warping, cupping, splitting cracking or shrinkage of the fascia and trim material; faulty or improper storage or installation of the Product; damage caused by foreign substances (including, but not limited to, chemicals, cleaning solutions, sap, etc.); acts of God (including, but not limited to, fire, lightning, hail, heavy rains, heavy winds, unusually high temperatures, hurricane, tornado, earthquake, etc.); failure to properly maintain the Product; surface deterioration due to pollution, mildew accumulation or scratching; defects in any structure to which the Product is near or attached.

**This Limited Warranty is non-transferable and non-assignable.**

## **CLAIM PROCEDURE**

A claim must be filed within thirty (30) days after the discovery of a possible defect or failure. To make a claim, contact your sales representative or send your claim in writing to:

Representatives of Warrantor must be granted access to the structure where the Product has been installed to allow Warrantor to inspect, take samples, or take photographs as part of an investigation of any claim.
